I am requesting \$750,000 in funding for the City of San Jose's Digital Inclusion, Virtual Learning, and Caregiver Support program in FY22. The entity to receive funding for this project would be the San José Public Library (SJPL), which is located at 150 E. San Fernando Street in San Jose, California 95112. SJPL will have citywide participant recruitment, and offer programming at various branches including the Alviso Branch at 5050 N 1st St, San Jose, CA 95002, Berryessa Branch at 3355 Noble Avenue, San Jose, CA 95132, and Educational Park Branch at 1771 Educational Park Dr. San Jose, CA 95133.

This funding would be used to build on San José Public Library's successful pilot program to serve the most vulnerable children in our community by providing professional training for family, friend, and neighbor (FFN) caregivers of children under the age of six. The funding would allow for expanded digital inclusion and technology support for caregivers to access virtual programming and additional resources to enhance the care they provide.

Dear Chair David Price and Ranking Member Mario Diaz-Balart,

As you begin your critical work on the Fiscal Year 2022 Transportation, Housing, and Urban Development appropriations bill, we strongly urge your inclusion of \$750,000 for the San José Public Library as a Community Project Funding project associated with the Economic Development Initiative account. This project would address inequities in access to quality childcare and school readiness. It would provide professional training and access to technology necessary for family, friend, and neighbor (FFN) caregivers to meet the needs of underserved children in San José. These funds would allow the San José Public Library to offer this essential programming citywide, including at the Alviso Branch located at 5050 N. 1st Street and at Bascom Branch located at 1000 S. Bascom Avenue.

This project builds on the crucial efforts of the San José Public Library to serve the most vulnerable children in our community by providing professional training for FFN caregivers of children under the age of six. The current FFN Caregiver Support Network has provided 60 FFN caregivers from San Jose access to high-quality workforce development training in child development, which increases and enhances quality of childcare environments, providing more equitable outcomes for families seeking care and those providing care. The funding would enable the existing successful pilot program to continue and allow for expanded digital inclusion and technology support for caregivers to access virtual programming and additional resources to enhance the care they provide.

Many families, especially those in underserved communities, rely on FFN caregivers when they can't afford to enroll their children in licensed childcare programs. By providing FFN caregivers with free, high-quality professional training, this project ensures the children in their care receive the support they need to be school-ready by the time they enter kindergarten. The funds will also be used to close the digital divide by providing caregivers with access to technology.

The project directly benefits marginalized communities, providing care in areas of San José which have an over representation of low-income households and have been deemed "high risk zones" by First 5 Santa Clara County, with demonstrated needs in the areas of low maternal educational achievement, high Medi-Cal enrollment, and higher incidences of child abuse and teen pregnancy.
